

## Tolls / Road Use Charge, Goods Transport Romania

## Road use charge

The Romanian road use charge, called 'rovinieta', which is compulsory throughout the Romanian road network, may be obtained from the offices of the National Road Administration at border crossing points, from some fuel petrol stations as well as from UNTRR regional branches. UNTRR has developed an <u>online application</u> in English, German, Hungarian, Russian, Turkish, Bulgarian, Polish and Serbian, which allows hauliers to buy rovinieta and Fetesti bridge. The "rovinieta" may be purchased by credit card up to 30 days before the starting date of the vignette.

Since 1 October 2010, the paper vignette system (sticker that used to be stuck on the windscreen) has been replaced by an electronic system. However, the driver still needs to go to one of the above mentioned selling points in order to pay for the electronic vignette of his choice. The driver will be asked to provide the vehicle's registration number as well as the vignette type and its period of validity. These data will be entered into the National Road Authority and police database. After paying the corresponding fee, the driver receives a receipt and an annex containing all relevant data that he should keep onboard the vehicle. Payment is automatically registered in the central system and is maintained throughout the period of validity for which the fee was paid. Once the validity has expired, the driver needs to go back to one of the selling points and pay for another vignette.

Inspections are conducted either via cameras or by inspection officers. Drivers who are not in possession of a valid rovinieta will be subject to a fine between RON 250 and 4,500 (~  $\in$  50 to  $\in$  900).

Categories of vehicles:

A – cars

B - goods transport vehicles with maximum total weight authorized less or equal to 3.5 t

C - goods transport vehicles with maximum total weight authorized more than 3.5 t and less or equal to 7.5t

D - goods transport vehicles with maximum total weight authorized more than 7,5 t and less than 12t

E - goods transport vehicles with maximum total weight authorized more or equal to 12 t, maximum 3 axles (including)

F - goods transport vehicles with total maximum authorized weight more or equal to 12 t, minimum 4 axles (including)

**Giurgiu – Rousse bridge** (Romanian/Bulgarian border)

- Tolls are levied before crossing the bridge in the direction of Rousse; they are levied on all vehicles, regardless of their country of registration.
- Tariffs for 20 crossings are valid for the same type of vehicle, based on prepaid stickers, valid until 31 December of each year.

    - Giurgiu Control and Collection Agency (A.C.I. Giurgiu)

The tariffs (VAT included) for the bridge across the Danube river between the towns of Calafat (Romania) and Vidin (Bulgaria) are as follows:
